# REGISTRATION BOOK

FOR A

Mechanically Propelled Road Vehicle

*Read carefully the following instructions.*

1. Upon the first issue of this Book sign your name in the top space provided on page 3.
2. **KEEP THIS BOOK IN A SAFE PLACE, NOT ON THE VEHICLE.** If you lose the book you may have trouble and delay in renewing the licence or in disposing of the vehicle; and you should report the loss at once to the Vehicle Registration and Licensing Department, Guernsey.
3. If the particulars on page 6 are not correct, inform the Registration Department at once.
4. If you make any changes in your vehicle which affects the motive power or particulars on page 6 (h.p., unladen weight, seating capacity, colour or type of body), you must at once inform the Registration Department and send this book to that Department. (It is an offence not to notify any change of the registration particulars). You must at the same time send the licence when the alteration affects any of the particulars thereon. If the alteration made increases the amount of licence duty payable, you should send a cheque for the amount of the additional duty.

### Renewal of Licence

5. When your licence is due for renewal, forward this book, together with renewal application form duly completed, your third party insurance certificate and remittance to the Vehicle Registration and Licensing Department, Guernsey.

The amount of tax due (provided there has been no alteration in the weight of the vehicle) is shown on page 7 of this book.

This book together with a new licence, will be returned to you without delay.

If this Vehicle is acquired by another person see page 5, Article 9.

If this Vehicle is broken up, destroyed or permanently out of Guernsey, see page 5, Article 6.

The Court may impose various penalties for the non-observance of the requirements contained herein.

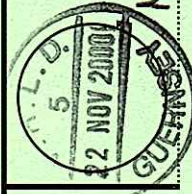
